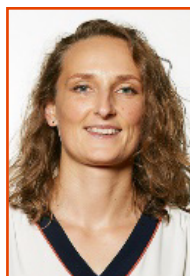
Adam Esses Assistant Coach

CAMP INFORMATION

HOW TO ENROLL

Complete the camp registration form (including waiver release) and it in along with payment or sign up online at utsawomensbasketballcamp.com.

Once registration and payment is received you will be sent a confirmation email along with more information about camp. Cancellations less than 48 hours before the start of camp will be charged for the first day of camp.

ADVANCED CAMP- JUNE 22nd- 23rd

This camp is designed for players looking to take their game to the next level. Open to all high school ages including those entering their freshmen year. This camp will provide players a chance to learn directly from the UTSA Women's Basketball coaches and players.

Campers have the choice to stay overnight or commute each day. Resident campers will stay in UTSA campus housing and be provided breakfast on Saturday morning. All campers will receive dinner on Friday and Lunch on Saturday.

Camp will begin at 1:00pm on Friday, June 22nd with check in beginning at 12:00pm. The first day of camp will end at 9:00pm. On Saturday, June 23rd camp will begin at 9:00am and conclude at 3:00pm.

YOUTH CAMP- June 25th- 27th

This camp is designed to teach fundamentals to a variety of different skill levels while having fun. It is open to incoming 5th through 8th graders.

Camp will begin each day at 9:00am and conclude at 12:00pm

FACILITIES

All camps will be held in the Convocation Center on the UTSA Main Campus.

EQUIPMENT AND CLOTHING

All campers are responsible for their own basketball shoes, t-shirt, shorts, socks and spending money. Overnight campers will need to bring their own bedding as well as a towel and toiletries for showering.

CAMP PARKING

Parking permits are \$10 and required for parking in front of the Convocation Center. UTSA Women's basketball camp is not responsible for any parking tickets. Permits will be available for purchase and pick up at check in.

MEDICAL

Each camper must have a medical waiver as well as insurance information on file prior to starting camp. A full time certified trainer will be on site to assist with any injuries that may occur at camp. If a camper needs to be taped they will need to bring their own supplies.
