#### **Team Camp**

This camp is for junior high and high school teams and poses an excellent opportunity for teams to play and work together on different situations in a highly organized atmosphere.

We are here to assist high school and junior high coaches in all areas of the game to improve their teams. We expect to have all players involved in a positive competitive situation and to develop a commitment to excellence. Strong efforts will be made to allow each camper to make friends, have fun, and enjoy a great weekend of basketball. The team camp will have two divisions: Junior High and High School.
